

CANCELLATION PROTECTION SCHEME.

Holidays are to be enjoyed and looking forward to it is part of the excitement but, unforeseen things can happen when you least expect it. Norbury Wharf offers a protection scheme for this eventuality. This is an optional scheme and for a small premium under the following circumstances detailed below, you can protect your holiday. This PROTECTION SCHEME gives you the option to protect your holiday through cancellation at any time before your holiday is about to start. In this event you will be absolved of all liability under the conditions of hire for any balance of charges due. If part of the holiday has already been paid, we will refund you your paid amount in full ***only if you have cover.***

Once you have paid the deposit for your holiday and it has been confirmed by us, a contract exists which renders you liable for the ***whole*** amount of the holiday, even if you are prevented from taking it. If you are not part of our CANCELLATION PROTECTION SCHEME your holiday is totally unprotected.

Our CANCELLATION PROTECTION SCHEME covers full cancellation of your holiday ***only***. If you are ***not*** part of this scheme you will have to cancel your holiday and you will be liable for the full cost of your hire and the full terms and conditions of hire as set out in this brochure, we will try to re-let the boat but, if we are unsuccessful you remain liable.

Qualifying Circumstances:

Please read carefully, it is very important.

- 1) DEATH, INJURY, ILLNESS OR PREGNANCY. (certified in all cases by a qualified medical practitioner only) jury service or witness call. This applies to people listed on the booking form at the time of booking only.
- 2) DEATH, INJURY OR ILLNESS (certified in all cases by a qualified medical practitioner only) of the spouse, civil partner, parent, children, parent in law or fiancé of the hirer, qualifying relative or any member of the listed people on the booking form at the time of booking only.
- 3) Redundancy of the hirer, providing that the hirer qualifies for payment under the redundancy payments act 1965.
